Report of the Chairman: The office space lease is currently on a month to month basis, the Chairman requested that a committee of Mike Pursell, Tony Privitera and Mike Graf review the lease and make a recommendation at the next Board meeting.

V. STANDING COMMITTEES

Image and Marketing Program: Aaron Mahr and Sharon Brown, Ph. D. from the National Park Service paid a visit to the Metropolitan area for an update on trail activities. They were briefed on the current status of the 3-Trails Corridor shared use bridge over I-435, the Pedestrian Intermodal Transportation Connector Plan wherein the 3-Trails Corridor is an integral part and the improvements to Schumacher Park.

Transportation Program: Wayne Flaherty was introduced as a volunteer rail liaison to the District. As a member of the Johnson County Transit Council, the Johnson County 2040 Visioning Committee and other transit organizations, he will report from time to time those rail activities which will effect the District. He has met with the engineers doing the design of the system and gave a brief report on activities relating to the **Regional Rapid Rail** project currently being planned.

City, State & Federal Capital Investment Grant Funding: The Chairman noted discussions were ongoing with the Metro ATA on use of the Federal CMAQ Transit Station funds for upgrades to transit stops within the District.

Maintenance, Grounds and Security: The trash dumping has slowed but still occurring. Effort to eliminate is to continue.

Education: The District lobbyist Mr. Benny Lewis is continuing efforts to get passage of a bill to clarify existing CID authority allowing the District to sponsor and operate a “science-tech specialty school” within the District. The Bill is in the “Job Creation and Economic Development Committee.”

Lewis & Associates, LLC for assistance in revising the Community Improvement District Statutes to clarify authority for the operation of a school. After discussion, a motion to adopt was made and seconded. The Resolution was approved unanimously.
